



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made effective as of **6th July 2025**

BETWEEN

AL-RAHMAN WITYYA

(84/1 m.7 t.tanjongmas a.ra'nget ch.naratiwat 96130 - Thailand)

AND

SEKOLAH TINGGI AGAMA ISLAM NURUL QADIM

(Desa Kalikajar- Kecamatan Paiton - Kabupaten Probolinggo – Indonesia)

Al-rahman wittya school, Thailand and STAI Nurul Qadim, Indonesia (here in after individually referred to as the “**Party**” and jointly referred to as the “**Parties**”) agree to enter into a formal callaborative agreement besed on a foundation of trust for understanding and goodwill.

Al-rahman wittya school, Thailand and STAI Nurul Qadim, Indonesia Desire to engage in cooperative educational and research activities, for the mutual benefit of both partners, the partners have agreed upon the following;

ARTICLE 1: AREA OF COOPERATION

The purpose as mentioned above will be accomplished by undertaking the following activities:

- a. Joint enrollment activities and campaingns for foreign student;
- b. Joint development of language and skill training standards, reseurses and programs to enterprises and other relevant parties;
- c. Exchange and training of academic and administrative faculty;
- d. Exchange of research materials, publications and information;
- e. Development and oparation of joint academic programs;
- f. Semester exchange programs;
- g. Service community;
- h. Calturan and academic exchange of student and staff;
- i. Other callaborations as mutually agreed;

In order to carry out the above mentioned activities, a detail plan is to be formed into specific activities agreements based on the mutual agreement of the partners.

ARTICLE 2: NON-BINDING LEGAL AND VINANCIAL

This MOU is intended only to set forth the general understanding of the partners with respect to the subject matter here in, and does not intend to, cantractually bind the partners, either in trem of legal or financial oblogation. The partners may enter into other agreements to achieve the purpose of this MOU.

ARTICLE 3: VALIDITY, AMENDMENT AND TERMINATION

- 3.1 This MOU is valid from the date of last signature by person authorized to bind each of partner, for period of 5 (five) years, and is renewal by the mutual written consent of the partners unless terminated sooner as provided herein and may be extended by the mutual written consent of the partners.
- 3.2 This MOU may be modified and/or amended through mutual discussion and written consent of the partners. Any agreed modification and/or amendement made during the validity period of the MOU shall be made as annexes to this MOU.
- 3.3 Subject to 3.1, this MOU shall remain in effect until termination by either partner, termination shall be effected by giving the other partner at lease ninety (90) days prior written notice of is intention to terminate.
- 3.4 termination shall be without penalty. If this MOU is terminated, neither partner shall be liable ti the other for any monetary or other losses which may result.
